AGREEMENT FOR BOARD OF HORSE

WHEREAS the Horse Owner warrants that he/she is the sole owner of the horse whose name, sex, age and color is as follows:

AND WHEREAS the Horse Owner desires the horse to be boarded at the Co-operative operating as the Red River Roping and Riding Club, hereinafter called "RRRR".

NOW THEREFORE in consideration of the items and conditions hereinafter specified, the parties agree as follows:

1) A)The Horse Owner and the RRRR mutually agree that the horse shall be boarded at the RRRR, hereinafter called "RRRR" from the

until the

_____ day of _____, 20____ or until this agreement is earlier terminated (herein called "the term")

B) At the option of the Horse Owner or RRRR, this agreement may be terminated without cause upon either party giving 30 days' notice to the other.

2) To assist in the proper care and handling of the horse, the Horse Owner provides the particulars of the restrictions and instructions upon Schedule A attached hereto and forming part of this Agreement.

- 3) The attached Schedule B forms part of this Agreement and assists in the identification of the horse.
- 4) The Horse Owner agrees that he/she shall make all arrangements for any farrier work for the horse, and assumes all the cost thereof. Any exceptions to this arrangement shall be given in the space that follows:

 - _____ The RRRR shall schedule regular farrier appointments for the horse, all handling costs associated with the scheduling will be my responsibility

- 5) During the Term, RRRR shall be responsible for all the horse's feeding, watering and turn-out requirements, the manager of the RRRR agrees that under normal conditions, he/she shall keep the horse in a stall, pasture or pen as follows:
 - a)Day _____

- 6) The Horse Owner agrees to pay RRRR for the foregoing facilities, feed and services the sum of _____ that day or month (payable on the 1st day of each month in advance).
- 7) RRRR is entitled to a lien against the boarded horse for the value of the services rendered, and shall be entitled to enforce said lien according to the applicable laws if the Horse Owner fails to make the payments required under this agreement at the times specified for payment. The horse shall not be removed from the facility until all amounts due and owing are paid.
- 8) In the event of any accident, injury or illness of the horse, the manager of the RRRR will contact the Horse Owner at:

If a veterinarian/healer is specified, the Horse Owner agrees that he/she shall be solely responsible for fees incurred for the services deemed by the veterinarian/healer to be appropriate, and the RRRR shall have no liability whatsoever for such fees.

- 9) Nothing herein shall be interpreted to interfere with the right of the Horse Owner to carry his/her own insurance in respect of the horse at his/her own expense.
- 10) Excepting to the extent of any insurable proceeds available through the insurance coverage which may be carried by RRRR (less the value of any deductible portion of the same) the Horse Owner agrees to release and in indemnify and save harmless RRRR, its directors, officers, employees, servants, agents, members,

instructors and volunteers(herein referred to as “RRRR agents” from all claims, actions, demands and cost in respect to the damage to, injury, loss, theft, or death of the horse howsoever cause including whether or not the cause was the result of or contributed to by the negligence of the RRRR or RRRR agents while the horse is at the RRRR facility.

- 11) In the event damage or injury occurs to the horse, due to the Horse Owner’s failure to advise on the Schedule A of any special restriction or instruction regarding the car, or handling of the horse; the Horse Owner shall indemnity and save harmless the RRRR and RRRR agents from all claims, actions, demands and costs in any way arising from the same.
- 12) Neither party may assign this Agreement without the written consent of the other.
- 13) This Agreement in the entire agreement and not terms, representations or warranties whether written otherwise shall apply unless signed by both parties.
- 14) This Agreement may be amended or altered at any time if in writhing and signed by both parties hereto..
- 15) Any notice herein provided for shall be sufficiently given by mailing, postage prepaid , by ordinary mail to RRRR addressed to: RR # 5 Site 19 Box 10 , Prince Albert, SK , S6V 5R3
