5)	During the Term, RRRR shall be responsible for all the horse's feeding, watering and turn-out requirements the manager of the RRRR agrees that under normal conditions, he/she shall keep the horse in a stall, pasture or pen as follows: a)Day

6)	The Horse Owner agrees to pay RRRR for the foregoing facilities, feed and services the sum of that day or month(payable on the 1rst day of each month in advance.
7)	RRRR is entitled to a lien against the boarded horse for the value of the services rendered, and shall be entitled to enforce said lien according to the applicable laws if the Horse Owner fails to make the payments required under this agreement at the times specified for payment. The horse shall not be removed from the facility until all amounts due and owing are paid.
