The Lessee is responsible for recording, collecting and handing in fees to the RRRR manager for arena daily fee, stabling or pens usage. 3. The Lessor is NOT responsible for any theft or damage to personal property while on the RRRR grounds. 4. Damage/clean up Deposit shall be returned the following day or as soon as possible and only if the grounds are left in the condition they were in at time of arrival. Any additional clean-up will be reported to Lessee and must be completed within a 24 hour period or The RRRR will charge a \$20/hr employee fee plus the hourly equipment rates as stated on this agreement. This is to be determined by the discretion of arena manger. 5. The Lessee is responsible to pay costs exceeding damage/clean up fee that have incurred to equipment or buildings/grounds during time of rental. 6. No RRRR equipment will be used without a RRRR employee operator. 7. Barrel, tables, chairs, garbage cans, posters, panels ect. Must me taken down, put away after end of event. 8. Horses cannot be tied on Arena surfaces at any time. Please tie on FENCES only. 9. Doors must be shoveled in winter and closed properly when leaving ARENA. 10. All gates must be checked and closed securely before leaving grounds. 11. Manure must be picked up from all riding arenas right away or when breaks occur in an event. 12. If you borrow something. Put it back where you took it from. 13. No dogs allowed in the indoor Arena or in/on the Bleachers. 14. NO SMOKING in the Indoor Arena. 15. The Lessee is responsible to ensure all COVID 19 protocols are followed, including proper sanitization and that occupancy rates are adhered to. | | | |
